These Warrants were not converted into the Equity shares of the Company before its expiry on the 04th January, 2024. The Company has already filed the Debit Corporate Action Form for 1,12,00,000 Warrants. Two Warrant holders (public category) aggregating 1,00,00,000 Warrants have filed the petition before the Honble National Company Law Tribunal (NCLT). The said matter was already settled by the Company with Warrant holders and the withdrawal application was filed by them before the NCLT. The NCLT has disposed the matter on the 13th February, 2026, the Company shall file Debit Corporate Action form in this regard soon.
