AND INFORMATION  
[AMENDING POLICY DATED 12<sup>TH</sup>  
AUGUST, 2017]**

## **Background**

Ansal Properties & Infrastructure Limited {including its subsidiaries, affiliates, associate(s), joint venture(s), group company (ies)} (hereinafter referred as the 'Company') believes in the conduct of its affairs in a fair and transparent manner by adopting highest standards of professionalism, honesty, integrity and ethical behaviour and in complete compliance of laws, as amended from time to time.

## **OBJECTIVE**

- To ensure systematic approach for protection, maintenance and availability of all the existing/ future events or information hosted on the website of the Company {[www.ansalapi.com](http://www.ansalapi.com)} after a period of five years.
- Events or information shall cover those disclosed to the Stock Exchanges by the Company.
- Removal of information from the website of the Company.

## **BRIEF OVERVIEW OF THE LEGAL PROVISIONS**

**Regulations 30(8) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 {SEBI Regulations}, as amended.**

The Company shall have an archival policy for availability of all the existing/ future events or information, which are disclosed {in short "the disclosures"} to the Stock Exchanges and hosted on the website of the Company {[www.ansalapi.com](http://www.ansalapi.com)} for a minimum period of five years.

## **AVAILABILITY OF THE EVENTS/ INFORMATION HOSTED FOR MORE THAN FIVE YEARS ON THE WEBSITE OF THE COMPANY**

All the disclosures made by the Company to the Stock Exchanges under Regulation 30(8) of the Listing Regulations shall be hosted on the website of the Company namely {[www.ansalapi.com](http://www.ansalapi.com)} for a minimum period of five {05} years. Thereafter, such disclosures shall be kept in the archives of the Company (FTP Server) for a period of two {02} years. Recipients shall have the option to freely download the disclosures during the said period of two

{02} years directly from the Company's website through a separate link provided at the Company's website.

### **AVAILABILITY OF THE EVENTS/ INFORMATION DISCLOSED UNDER OTHER STATUTES/LEGISLATIONS**

All information required to be uploaded on the Company's website in pursuance of any other statute / legislation / regulation, shall be hosted on the Company's website, in the form, manner and for such period as may be mandated by that statute / legislation / regulation etc.

### **REMOVAL OF EVENTS/ INFORMATION**

Removal of events/ information from the FTP server of the Company after seven {07} years period shall be under the authority, guidance and directions of the Company Secretary {CS} and IT officer.

### **EXISTING EVENTS OR INFORMATION**

All existing events or information hosted on the website of the Company shall be archived in terms of this Policy.

### **DISCLOSURE**

This Policy shall be disclosed in the Company's web site.
