IMPORTANT ANNOUNCEMENT FOR HOMEBUYERS/ ALLOTTEES

Dear Homebuyers/ Allottees,

This is in continuation of the announcement dated 31.07.2025 (effective from 01.08.2025) made by the Resolution Professional of Ansal Properties and Infrastructure Limited (APIL). Procedure to be followed:

- 1. Initial Contact Approach the authorised employees at the respective project site (details provided below).
- 2. Submit documents The concerned homebuyer or allottee is required to submit the complete set of documents along with the request for transfer/registration to the authorised employees of Corporate Debtor.
- 3. Verification The Corporate Debtor employees will verify the documents and confirm completeness/discrepancies, if any.
- 4. Guidance on Charges The team will guide the concerned allottee/homebuyer regarding applicable stamp duty, registration fees, and any other statutory charges.
- 5. Preparation of Documents Obtain proforma agreements/ transfer formats from authorised employees and complete them as instructed.
- 6. Appointment & Execution Appointments for registration/transfer at the Sub-Registrar office and coordinate for execution
- 7. Handover of Copies After successful completion, copies of documents will be handed over to the allottee/homebuyer.
