3. The Acquirer {Sushil Ansal} and the transferor {Sushil Ansal and Sons (HUF)} are the part of Promoter and Promoter Group. The aggregate shareholding of the Promoter and Promoter group prior and after the aforesaid transaction has remained unchanged. Consequent to the dissolution/partition of Sushil Ansal & Sons (HUF) and transfer of aforementioned shares, the Sushil Ansal & Sons (HUF) ceased to be part of Promoter Group of Ansal Properties & Infrastructure Limited.




