POST NOTICE EVENT

- 1. The notice of the 45th meeting of CoC was sent 5 days prior to the CoC meeting i.e., 11.12.2025 by electronic means at the Email id of the Authorized Representative of Home Buyers, unsecured financial creditor and Directors (Powers Suspended) of Corporate Debtor, as per the record handed over by the Erstwhile RP and obtained from Public Domain.
- 2. The Authorized Representative of Home Buyers was also informed by the team of Resolution Professional about the 45th CoC meeting telephonically to ensure receipt of notice and also took confirmation for their participation.
- 3. The notice was sent to the Directors (Powers Suspended) of corporate debtor at their email ids available on the MCA portal.
- 4. The link to attend the meeting was shared with Authorized Representative of Home Buyers, unsecured financial creditor and Directors (Powers Suspended) of Corporate Debtor along with the notice on 11.12.2025.

CONDUCT OF THE MEETING

The meeting started at around 06:00 P.M. Approximately One Hundred Eighteen (118) Homebuyers virtually joined the COC meeting, however, despite multiple requests from the RP, certain homebuyers did not mention their names along with details of their respective units. Further, Ms. Aakriti Sood (Authorized Representative of Home Buyers) as well as Mr. Vinod Kumar Saini, unsecured financial creditor also participated virtually.

The RP and his team members attended the meeting physically from Chandigarh Office. Further, two team members of RP joined the meeting through audio-video means. The attendance of the participants who were present in the meeting was marked by the team members of RP, who attended the meeting.

Mr. Jalesh Kumar Grover, Resolution Professional of M/s Ansal Properties & Infrastructure Limited (Fernhill Project, Gurugram), for conducting its Insolvency Resolution Process took the chair and the meeting was called to order.

1. The Chairperson took the roll call of all the participants attending the meeting and announced their name, the name of the members of COC whom they were representing, and

a confirmation was taken from every participant that they have received the agenda and notice of the meeting.

- 2. The Chairman enquired whether any belated claimant had joined the meeting and, if so, requested them to exit, as they are not members of the CoC, yet.
- 3. The Chairperson informed the participants that the required quorum is complete and meeting can be proceeded with and also informed the participants that the meeting shall have the presence of quorum throughout the meeting.
- 4. The Chairperson also informed the participants that as per Regulation 25(5) of IBBI (Insolvency Resolution Process of Corporate Persons) Regulations, 2016. The resolution professional shall:
 - (a.) Circulate the minutes of the meeting by electronic means to all members of the committee and the authorized representative, if any, within forty-eight hours of the conclusion of the meeting; and
 - (b.) Seek a vote of the members who did not vote at the meeting on the matters listed for voting, by electronic voting system in accordance with Regulation 26 where the voting shall be kept open from the circulation of the minutes, for such time as decided by the committee which shall not be
 - (c.) less than twenty-four hours and shall not exceed seven days:
 - *Provided* that on a request for extension made by a creditor, the voting window shall be extended in increments of twenty-four hours period:
 - *Provided further* that the Resolution Professional shall not extend the voting window where the matters listed for voting have already received the requisite majority vote and one extension has been given after the receipt of requisite majority vote.
 - (d.) As per Regulation 25 (6) of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations 2016, the Authorised Representative shall circulate the minutes of the meeting received under sub-regulation (5) to creditors in a class and announce the voting window at least twenty-four hours before the window opens for voting instructions and keep the voting window open for at least twelve hours.

AGENDA ITEM NO. 45.01

THE RESOLUTION PROFESSIONAL TO TAKE CHAIR OF THE MEETING AS PER REGULATION 24 OF THE IBBI (CIRP) REGULATIONS, 2016

Mr. Jalesh Kumar Grover, having registration number IBBI/IPA-001/IP-P00200/2017-2018/10390 was appointed as Resolution Professional ('RP') in the matter of M/s Ansal Properties and Infrastructure Limited (Fernhill Project, Gurugram) by the Hon'ble NCLT, New Delhi Bench, Court– II vide its order dated 10.01.2024.

In accordance with Regulation 24(1) of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations, 2016, Mr. Jalesh Kumar Grover, Resolution Professional of M/s Ansal Properties and Infrastructure Limited (Fernhill Project, Gurugram) took the Chair as Chairperson and the meeting was called to order.

The committee took note of the same.

AGENDA ITEM NO. 45.02

TO ASCERTAIN THE QUORUM OF THE MEETING AS PER REGULATION 22 OF IBBI (CIRP) REGULATIONS, 2016

The Chairman apprised the committee that as per Regulation 22(1) of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations, 2016, the quorum for the meeting of the committee of creditors is achieved if members of the committee representing at least 33% of the voting rights are present either in person or by video conferencing or other audio-visual means; provided that the committee may modify the percentage of voting rights required for quorum in respect of any future meetings of the committee.

Pursuant to the above provisions, the Chairman ascertained that the requisite quorum is present as Ms. Aakriti Sood, Authorized Representatives of the allottees as well as Mr. Vinod Kumar Saini (Unsecured Financial Creditor) having 100% voting rights in the COC, are present at the meeting and accordingly, the COC meeting was declared open.

AGENDA ITEM NO. 45.03

TO GRANT LEAVE OF ABSENCE TO THE MEMBERS, IF ANY

The Chairman apprised that no request for grant of leave has been received by the RP. Hence, no leave of absence was granted to any member/participant. The Chairman further apprised that the Directors (powers suspended) of the CD did not attend the meeting/ never attended the meeting, in spite of due service of notices to them.

The Committee took note of the same.

AGENDA ITEM NO. 45.04

TO APPROVE AND CONFIRM THE MINUTES OF THE 44th COC MEETING HELD ON 19th NOVEMBER, 2025 AT 06:00 PM.

The Chairman apprised the committee that the minutes of the Forty Fourth COC meeting held on 19.11.2025 as approved by the RP had been circulated to all the participants electronically within 48 hours of the meeting i.e., on 21.11.2025 in accordance with Regulation 24, sub-regulation (7) of the IBBI (CIRP) Regulations, 2016. A copy of the minutes of the 44th COC meeting was attached with the notice of the instant meeting as Annexure-45.04.01.

The Chairman requested the committee to share their observations, if any, on the minutes of the 44th COC meeting dated 21.11.2025. No observations were received from AR / any members in this regard.

Accordingly, the minutes of the 44th COC meeting held on 19.11.2025 stood approved by the members of the committee.

AGENDA ITEM NO-45.05

TO APPRISE THE COMMITTEE REGARDING THE STATUS OF ONGOING LITIGATIONS

The Chairman apprised the CoC that all the matters were last listed for hearing on 17.11.2025. During the course of the hearing, after considering the submissions made by the parties in the Applications pertaining to admission of claims by the Resolution Professional, the Hon'ble Bench

observed that the SRA may address the said claims, as these were duly reflected in the books and accounts of the Corporate Debtor and were also verifiable as per the Resolution Professional. The counsel of SRA, on instructions stated that the SRA is willing to address all the objections to the resolution plan. After hearing the counsels in detail including the counsel for the SRA, the Hon'ble Bench was pleased to remand the Resolution Plan submitted by the SRA back to the CoC for reconsideration in accordance with judicial precedents. Consequently, I.A. No. 28 of 2024 (Plan Approval Application) stood disposed of. The RP was also present physically before the Hon'ble NCLT on 17.11.2025.

The Chairman further apprised the CoC that, in view of the disposal of the Approval of Resolution Plan Application bearing IA No. IA-28/ND/2024, the Hon'ble Bench was also pleased to dispose of the following Applications: IA-3704/2024, IA-3730/2024, IA-3702/2024, IA-4008/2024, IA-4056/2024, IA-4171/2024, IA-4252/2024, IA-4460/2024, IA-4597/2024, IA-4995/2024, IA-5173/2024, IA-6086/2024, IA-1986/2025, IA-2303/2025, IA-4581/2025, IA-4657/2025, IA-4660/2025, IA-4661/2025, IA-4697/2025, IA-5011/2025, IA-5052/2025.

The RP further apprised the CoC that thereafter, the counsel for the RP apprised the Hon'ble Bench regarding I.A. No. 4742 of 2025 filed by the RP regarding the non-cooperation of Samyak Projects in view of the Order dated 06.06.2025 passed by the Hon'ble Bench. Meanwhile, Mr. Rachit Mittal, Counsel for the Homebuyers' Association, submitted that an application bearing I.A. No. 3664/ND/2025 had been filed by him against Samyak Projects pursuant to the Order dated 06.06.2025 seeking expansion of the CIRP. After hearing both sides, including Senior Counsel Mr. Vivek Kohli appearing for Samyak Projects, the Hon'ble Bench listed all the Applications filed in terms of the Order dated 06.06.2025 for further consideration on 28.11.2025.

On the last date of hearing i.e., 28.11.2025, the matter was mentioned at the time of presiding of the Hon'ble Bench by Mr. Rachit Mittal being counsel for Home-buyers Association addressing the hindrance created by Samyak Projects and pendency of Contempt Petition.

Thereupon, the Hon'ble Bench was of the view that first the main issue has to be decided in accordance with the order dated 17.11.2025, wherein the Resolution Plan was remitted back to the CoC and further listed the matter for consideration on 19.12.2025.

Thereafter, the RP apprised the CoC regarding the status of each ongoing litigations in the matter of M/s Ansal Properties & Infrastructure Limited (Fernhill Project, Gurugram), which are as follows:

TO APPRISE THE COC REGARDING EXTENSION OF CIRP PERIOD BY 60 DAYS GRANTED BY THE HON'BLE NCLT, NEW DELHI BENCH

The Chairman apprised the CoC, that as discussed in the previous CoC meeting, the Hon'ble NCLT remitted back the Resolution Plan to the CoC, for reconsideration, in accordance with judicial precedents. Consequently, the extension of CIRP Period was required, to enable detailed deliberations and to facilitate the reconsideration of the Resolution Plan in compliance with the Hon'ble NCLT's directions, since the extended CIRP period has already expired on 14.06.2024. Subsequently, after due deliberations in the meeting, the CoC approved the exclusion of CIRP period elapsed since the filing of resolution plan application and further extension of CIRP period by 60 days of CIRP period from the date of order of Hon'ble NCLT allowing extension application, through its e-voting results dated 25.11.2025 on the agendas discussed in the 44th COC meeting held on 19.11.2025.

Accordingly, the RP filed an extension application bearing I.A. No. 5871 of 2025 before the Hon'ble NCLT on 29.11.2025, which was listed before the Hon'ble NCLT on 02.12.2025, wherein the Hon'ble Bench was pleased to allow I.A. No. 5871 of 2025, thereby extending the CIRP period by 60 days with effect from 17.11.2025, i.e., the date on which the Resolution Plan was remanded back to the CoC for reconsideration. Accordingly, the CIRP period now stands extended till 16.01.2026.

The RP further apprised the CoC that it is intended to place the revised Resolution Plan for approval in the meeting proposed to be held on 29th December. Thereafter, the voting lines shall remain open until 5th January, 2026. Subsequently, the RP shall file the Resolution Plan application before the Hon'ble NCLT within one week.

The committee took note of the same.

TO DISCUSS THE REVISED PROPOSAL SUBMITTED BY THE M/S KRISH INFRASTRUCTURE PRIVATE LIMITED

The Chairman apprised the CoC that, as informed in the previous agenda, during the hearing held on 17.11.2025, the Hon'ble Bench observed that the SRA may consider the belated claims, as these appear to be genuine, duly reflected in the books and accounts of the Corporate Debtor, and verifiable as per the Resolution Professional. Further, during the hearing, the counsel of the SRA, on instructions also stated that the SRA is willing to address all the objections to the resolution plan. Consequently, the Chairman informed the CoC that the Hon'ble Bench remanded the Resolution Plan submitted by the SRA back to the CoC for reconsideration in accordance with judicial precedents.

In compliance with the directions of the Hon'ble NCLT, the Resolution Professional had requested M/s Krish Infrastructure Private Limited, to submit a revised proposal at the earliest.

The Resolution Professional had been in regular communication with the Resolution Applicant in this regard and the revised proposal was received via mail on 12.12.2025. Subsequently, the same was shared with the AR of the Class of Homebuyers and was advised to share the same with Homebuyers (*subject to receipt of the duly signed confidentiality undertaking*).

The RP further apprised the CoC that the received Resolution Plan has also been shared with the legal counsel for vetting, and upon receipt of the same, the RP shall share the observations with the Resolution Applicant.

The RP further apprised the CoC that the Resolution Plan has been shard with all the Homebuyers whose duly executed Confidentiality Undertakings had been received by the AR, Miss Aakriti Sood.

Additionally, a meeting with the homebuyers was scheduled and held on Sunday, i.e., 14.12.2025, during which certain observations/queries were raised by the homebuyers. After collating all such

observations/queries, the same were shared with the Resolution Applicant, for their consideration, so that the same may be addressed/clarified by the RA during today's meeting, wherein the Resolution Applicant has been invited for a detailed discussion on the revised plan.

Mr. Sunil Aggrawal, Rajat Singhal & Mr. S.K. Singhal joined the meeting on behalf of PRA - M/s Krish Infrastructure Private Limited.

Subsequently, RP discussed all the quires/ observations of the Homebuyers & RP with the representatives of RA. Thereafter, the RP invited the homebuyers, who were attending the meeting virtually, to raise their queries one by one. The RP further apprised that, if any further discussion or clarification be required in relation to the revised proposal, the same will be communicated to representatives of RA in due course.

Lastly, the RP apprised the CoC that the brief of discussions on queries/ observations raised by the CoC members will be shared after the circulation of the minutes of the meeting.

The Committee took note of the same.

The Chairman apprised the CoC that the pursuant to the Hon'ble NCLT order dated 17.11.2025 wherein, the Bench remitted back the Resolution Plan, which had been filed vide I.A. No. 28/ND/2024 by the Resolution Professional for approval, on the ground that the SRA would have no impediment in submitting a revised plan after taking into account such claim of homebuyers which could be duly verified by the Resolution Professional and found acceptable.

Subsequently, in compliance of the above-mentioned order, the Resolution Professional reconstituted the Committee of Creditors on 04.12.2025 after verifying all the claims received from Homebuyers received after 11.11.2024 *i.e.*, the date of issuance of the RFRP till 17.11.2025.

The RP further apprised the CoC that the revised constitution of the CoC was shared with the members via email dated 06.12.2025. Additionally, the application to place the revised constitution on record has been filed before the Hon'ble NCLT on 08.12.2025.

Further, Regulation 16A sub regulation 8 (d) provides that the fee for any additional meeting beyond two meetings corresponding to a meeting of the committee of creditors shall be part of insolvency resolution process cost subject to approval of committee of creditors.

The Chairman further apprised the committee that the AR has submitted an invoice for the 3rd meeting held with the allottees, post 43rd CoC meeting held on 23.10.2025. In light of the abovementioned regulations, the Chairman sought the approval of the committee in respect of the additional one meeting held by the AR.

The RP further apprised the CoC that the ratification of the fees for the two meetings conducted by the AR has already been sought in the previous agenda.

Accordingly, after due discussion and deliberation upon the said matter, it was decided that the following resolution shall be placed for seeking approval of the COC members through e-voting:

One of the homebuyers raised a query regarding the timeline for receipt of the legal opinion on resolution plan The RP clarified that the entire revised Resolution Plan has been submitted for legal vetting, and the legal opinion/observations on Revised Plan is expected to be received within 2–3 days.

The RP further informed that certain amendments are proposed to be incorporated in the Resolution Plan. In this regard, Mr. Sunil Agarwal, representative of M/s Krish Infrastructure Private Limited has been requested to visit NCLT for a joint meeting with all the legal counsel on Friday, 19.12.2025.

Additionally, the RP apprised that the legal observations of the Revised Resolution Plan shall be shared with the CoC members upon receipt of the same from Counsel.

One of the homebuyers raised a query regarding the legal transfer of the unit to the legal heir, stating that the unit originally belonged to the homebuyer's late father, and sought clarification on the procedure for effecting such transfer after the death of the original allottee.

The RP clarified that the procedure shall be shared with the concerned homebuyer via email.

One of the homebuyers raised a query regarding the treatment of EDC/IDC amounts paid while dealing with Ansal Properties and Infrastructure Limited (Corporate Debtor) prior to CIRP, specifically seeking clarification on how those payments would be treated under the Resolution Plan.

RP clarified that the amounts already paid towards EDC and IDC shall be adjusted and subtracted from the total unit cost.
