These results have been prepared in accordance with the recognition and measurement principles of the Companies (Indian Accounting Standards) Rules, 2015 (Ind AS) prescribed under Section 133 of the Companies Act, 2013, other accounting principles generally accepted in India and are in compliance with the presentation and disclosure requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosures Requirements) Regulation, 2015 (as amended).

4. The equity shares of the Company got listed on BSE Limited ("BSE") and National Stock Exchange of India Limited ("NSE") on February 06, 2024.

5. The Company has received an amount of Rs 30,929.29 lakhs being Gross proceeds from fresh issue of equity shares. Net proceeds after issue expenses in relation to fresh issue are proposed to be utilized and the utilization thereof are summarized as below:

IPD proceeds which were - utilized as at December 31, 2025 were temporarily invested in term deposit amounting to Rs. 15,720.00 - lakhs with scheduled bank and the balance amounting to Rs. 107.96 - lakhs.

6. The Board of Directors at its meeting held on February 05, 2026, has declared an Interim Dividend of Rs. 0.50/- per equity share.

7. On November 21, 2025, the Government of India notified the four Labour Codes, consolidating 29 prior laws. The Ministry of Labour & Employment released draft Central Rules and FAQs to assess financial impacts.

8. The Group has assessed and disclosed the incremental impact consisting of gratuity of Rs. 28.41 lakh within the employee benefit expense. The Group continues to monitor the finalisation of Central / State Rules and clarifications from the Government on other aspects of the Labour Code and would provide appropriate accounting effect on the basis of such developments as needed.

9. During the period from 26 November 2024, the Company acquired 57% equity share capital of Aedifics Solutions Private Limited (ASPL) and the 100% subsidiary Safinet Advisory Private Limited for a cash consideration of Rs. 778.98 lakhs, subject to adjustments mutually agreed between the parties to the transactions.

10. The above consolidated financial results for the quarter ended December 31, 2025, include the results of ASPL which was acquired on November 26, 2024 and hence not comparable with previous period.
